**1. CALL TO ORDER**

5a. Approval of Minutes – January 8, 2019

6a. Status Update on Installation at 6 Sites

All 6 sites installations were completed and are waiting on the repair of El Segundo Water Tower Roof in the upcoming weeks. Chairman Lee reported the extension of the grant with the City of Los Angeles until the end of March.

6b. Status Update on Backup Link to ICI System

Executive Director Gallo reported the projection the issuance of the order to be completed by March 25.

## **6. ACTION ITEMS**

### **7a. Acceptance Testing**

Vice Chair Edwards reported the performance coverage acceptance testing in two weeks will involve two vehicles from Torrance and RCC personnel paired with Motorola driving to over a thousand stopping points. It is emphasized to conduct additional testing aside from the Motorola testing to help identify other issues. Once all 6 sites are live, it is encouraged to do their own testing at known trouble spots that are below grade, underground, and within buildings. This will distinguish between the Motorola coverage and the city.

### **7b. Manhattan Beach Water Tower – Decision**

Options are de-installation of equipment and reinstall after the 6-9 months or move installation to the scaffolding. Executive Director Gallo reported on the worksheet of the flowcharts of costs assessment and options. Discussion with Manhattan Beach, the JPA, and RCC will take place for funding source. Once the 6 sites are up and tested, bring down Manhattan Beach and reassess if the 5 sites provide enough coverage to help determine the next course of action.

### **7c. INSB Nomination/ Discussion for ICI System Technical Committee Representation**

Executive Director Gallo reported the start of discussion for primary alternate for ICI Governance, Operations, and Technical committees. ICI approved the membership and is waiting for INSB to go live.
