RECOMMENDATION

Staff recommends that the Board of Directors adopt a resolution appointing standby officers for the position of Executive Director.

DISCUSSION

Under California law, the Authority may provide for the succession of officers who head departments having duties in the maintenance of law and order or in the furnishing of public services relating to health and safety. To provide for the continuance of the Authority's operations during a state of emergency, the Board of Directors has the power to appoint up to three standby officers for the Executive Director.

In order to ensure continuity of operations during an emergency or disaster, staff recommends that the following positions, in the order listed, be appointed to serve as standby officers for the Executive Director in the event the Executive Director is incapacitated or otherwise unable to perform his duties:

1. Administrative Services Manager
2. Operations Manager
3. Finance & Performance Audit Manager

Under the By-Laws, the Executive Director has the power and duty to administer the affairs of the Authority and to appoint and direct all employees. As such, the Executive Director

has the authority and responsibility for establishing lines of succession for his subordinates. These designations are established by a direct written order of the Executive Director and do not require action by the Board of Directors or the Executive Committee.

RESOLUTION OF THE BOARD OF DIRECTORS APPOINTING STANDBY OFFICERS FOR THE POSITION OF EXECUTIVE DIRECTOR

WHEREAS, Government Code Section 8635 *et seq.*, entitled “Preservation of Local Government,” sets forth a procedure to provide for the continued functioning of political subdivisions in the event of a state of war emergency, state of emergency, or local emergency;

WHEREAS, Government Code Section 8638 authorizes the governing body of a political subdivision to provide for the continuance of the political subdivision’s legislative and executive departments during a state of war emergency, state of emergency, or a local emergency by appointing standby officers for the chief executive of the political subdivision;

WHEREAS, the Executive Director is the chief executive of the South Bay Regional Public Communications Authority;

WHEREAS, Government Code Section 8638 provides that standby officers shall be designated numbers 1, 2, and 3 in descending order of succession;

WHEREAS, pursuant to Government Code Section 8641, a standby officer is to fill the appointed post when the regular officer is unavailable as defined in Government Code Section 8636, and is to serve in such post until such time as the regular officer becomes available or a new regular officer is elected or appointed; and

WHEREAS, the qualifications of each standby officer named in Section 2 below have been carefully reviewed and each designated person has been determined to be an appropriate designee.

NOW, THEREFORE, the Board of Directors of the South Bay Regional Public Communications Authority does hereby resolve as follows:

Section 1. The individuals operating in the following positions are appointed, in order, as standby officers for the Executive Director:

1. Administrative Services Manager
2. Operations Manager
3. Finance and Performance Audit Manager

Section 2. Pursuant to Government Code Section 8640, each standby officer shall take the oath of office required for the position of Executive Director. Persons appointed as standby officers shall serve in their posts as standby officers at the pleasure of the Board of Directors and may be removed and replaced at any time with or without cause.
