Thomas Luce, resident of Manhattan Beach, reiterated his support for unencrypted radio for dispatching channels for police and fire in real time.

**4. APPROVAL OF MINUTES**

a. Approval of Operations Committee Minutes – August 10, 2021

## **5. GENERAL BUSINESS FOR OPERATIONS COMMITTEE**

### **a. LA-RICS Interoperability**

Lt. Phillips introduced Mr. Gordon Arnold to discuss some of the details of LA-RICS interoperability. Chair Faro reported to joining ICI Governance meeting last month and updated the committee on topics discussed, particularly LARICS system. City of Inglewood is the only city using the LA RICS. LARICS/INSB ISSI connection is up and running. . ISSI tested by Chair Faro and Officer Slawson with LARICS, communications good. The issue is LA RICS system is not sanctioned by Motorola. Furthermore, no MOU in place between ICI-S and LARCIS on how interoperability talkgroups will function. Mr. Arnold heard from Motorola that they were in process of testing LARICS system. Slawson – SB agencies are part of the ICI, working at the games at the stadiums. LARICS talkgroups are used at the stadium. Mr. Arnold noted reported unnoticed outages with LA RICS which is a concern for INSB if planning to use LARICS talkgroups. The INSB will have to have a channel patched to a consolette with LARICS talkgroup, obtain MOU with LARICS and requesting municipality, or the agencies have to use LA-RICS radios. The Chiefs will need to discuss with ICI-S for the approval from Motorola using the ISSI for connectivity.

### **d. Discuss switching to bi-monthly Technical Committee meetings to follow INSB JPA**

In the last Governance meeting, it was approved change meeting schedules to bi-monthly. November is off to regulate to their schedule.

### **e. MHB site/relocation**

Subcommittee have met and plan to compare four sites to the Manhattan Beach. The four sites include Grandview, Manhattan Beach Police Department, along the coast by 26 lifeguard building in LA County and options for 60 ft. tower and expanding to 100 ft. Tower. Coverage analysis to include current Manhattan Beach Water tower site in conjunction with the current system with no Manhattan Beach Tower. Determine the work with comparison to the other sites. The two attached quotes are preliminary and the subcommittee will continue to meet for discussion.

### **f. ICI-S Technical Update**

No update aside from LA RICS since there was no meeting.

### **g. Technical Issues**

The warranty on Juniper switches have approached end of life. Mr. Arnold added juniper routers are currently supported but they will not have support service agreements to the routers. MPLA maintenance is important to operations for assessing cyber security. information forthcoming. No infrastructure issues to report.
